Letter of Authorisation – LEI request

Important information about the form on the next page

Company representation: A company seeking to obtain, renew or transfer a Legal Entity Identifier („LEI“) may apply for such services:

- directly from GS1, through an authorized signatory within the company, or
- it may grant a limited power of attorney to an agent (external to company) to obtain those services on its behalf.

Multi-Year LEI: You can select to get an LEI with a one-year term, or if you want to avoid the hassle, for a three- or five-year term. If you decide to opt for a three- or five-year term, the form on the next page *a/so* includes an authorization by your company to GS1 to renew your LEI on your company's behalf and perform the validations to renew your LEI every year. Every year GS1 (or our registration agents, who are trained to support this) will verify your data.
